Job Title: Beer Vendor
Department: Food and Beverage
Reports To: Concessions Manager

Summary:

Sells beer to customers during events by carrying product up and down aisles, stairs and hallways and announcing the product to guests.

Essential Duties and Responsibilities include the following. Other duties may be assigned.

- Gathers supplies at beginning of shift.
- Generates the sale of beer before and during the event in a courteous, friendly manner.
- Sells beer at an event by walking around an announcing product to guests.
- Provides high quality customer service at all times.
- Refills supplies when necessary.
- Maintains equipment and cleanliness of vending cart as needed.
- Maintain accurate inventory and cash control.
- Follows cashing out procedures.
- Strictly adheres to beer shut off policy for each event.

Qualifications

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required. - 6 months – 1 year experience in sales/vending experience preferred.

- Must be self-motivated, outgoing and able to work under pressure in fast paced environment.

- Able to understand directives and utilize basic mathematical skills

- ServSafe certification a plus.
